Learner Warranties

The learner warrants that all information and documents supplied are accurate, authentic, and correct.

Course Requirements

- The learner must be 18 years old to enroll for eCornell.
- The learner is advised to consult our Learning Consultant on the preferred eCornell course as some eCornell courses have prerequisites before enrolment.
- A learner should have adequate English written skills, both written and spoken, as the courses will require interaction among learners and with the instructor as well.

eCornell Courses & Certificates

- Most eCornell courses run for 2 weeks Except for a few courses under certain competency domains which run for 3 or 4 weeks.
- eCornell Certificate programs are valid for 2 years. A learner can complete within the recommended time or complete the certificate program within 2 years.
- Once the course period ends, one additional week will be given to access the course content from the Canvas Dashboard. This will provide an opportunity to



download and save any files the learner wishes to keep, print the course content or do a final review of the course discussion boards, etc. Take Note, however, that unless given a time extension, the learner can no longer do any of the assignments, submit, or interact with fellow learners and the facilitator during this period. After this, the course will be archived and can be found by clicking Courses > All Courses from the Canvas Dashboard."

• It is highly recommended that learners read newsletters that we send periodically to learn more about course promotions and new courses offered.

Certificate & Letter of Completion

- A Cornell University certificate shall be awarded to a learner upon completing all courses in his/her certificate.
- An electronic copy can be downloaded from your student account, or you can purchase a printed or plaque version.
- A learner only taking a course shall receive a letter of completion, which can be downloaded through his/her student account.

Course Schedules

- The learner is advised to choose a course schedule starting at least 3 weeks in advance to have a better chance of reserving a seat.
- eCornell courses usually commence twice a month, every Wednesday, and are filled in quickly.
- eCornell reserves the right to adjust the course start date if necessary.
- If the course start date is full, an alternative schedule will be provided to the learner.

Registration, Enrolment & Postponement

- The learner shall fill in registration details and preferred course via https://genashtim.sg/ecornell/retail-courses/

Extension & Refund
